

INFORMATION NOTICE ON THE PROTECTION AND PROCESSING OF PERSONAL DATA

This Information Notice on the Protection and Processing of Personal Data ("Information Notice") contains the declarations and explanations regarding the processing of personal data belonging to natural persons within the scope of the Law on the Protection of Personal Data No. 6698 ("Law"), limited to the purposes of data processing and data categories detailed below, due to the operation of the website www.mallofistanbul.com.tr ("Platform") by Torunlar Gayrimenkul Yatırım Ortaklığı Anonim Şirketi ("Company"), acting as the data controller. The Data Subject declares, accepts, and undertakes that he/she has been informed about the processing of his/her data within the scope of the Law by means of this Information Notice on the Protection and Processing of Personal Data, and that he/she consents to the processing of his/her data.

1. Which Data Are Processed by Torunlar REIC?

The Company has the right to process general and special categories of data of the data subject with his/her explicit consent and, without explicit consent, in cases stipulated in Articles 5 and 6 of the Law.

Within this scope, in line with the terms and conditions set out in this Information Notice, the following types of "personal data" may be processed on the Platform:

- Personal data such as name and surname
- Contact data such as telephone, e-mail, and fax number
- Customer comments, feedback, and complaint data

2. For What Purposes Are Personal Data Processed by Torunlar REIC?

The Company processes personal data for the following purposes, among others:

- Recording name, surname, address, and other information for communication purposes
- Evaluating customer complaints and suggestions regarding our services

3. What Measures Are Taken Regarding the Protection of Personal Data?

The Company undertakes to take all necessary technical and administrative measures, and to have all required audits performed in a timely and complete manner, in order to ensure the protection of personal data, to prevent unlawful processing of personal data, to prevent unlawful access to personal data, and to prevent data breaches, under the conditions set out in the Law and in this Information Notice.

4. To Whom Are Personal Data Transferred?

Your collected personal data may be shared with third parties in Turkey and/or abroad with whom Torunlar REIC has a contractual relationship, for storage or lawful purposes stated in this Information Notice, and with public institutions and organizations legally authorized to request such data.

5. How Long Are Personal Data Retained?

The Company retains the relevant personal data for as long as required by the purposes specified in this Information Notice. Upon expiry of such periods, the personal data in question are deleted or destroyed in compliance with the Law.

6. What Are Your Rights as a Data Subject?

Within the scope of the Law, you may contact Torunlar REIC at any time to obtain information on the following matters:

- To learn whether your personal data are being processed,
- To learn the purpose of processing and whether it is being used in line with that purpose,
- To know to whom your personal data are transferred,
- To request correction of incomplete or inaccurate data, and if the conditions are met, to request deletion of personal data and to request notification of such correction/deletion to third parties to whom the personal data have been transferred,
- To object to the emergence of a result against you through the analysis of processed data exclusively via automated systems,
- To request compensation if you incur damage due to unlawful processing of your personal data,
- To request deletion or destruction of personal data if the reasons requiring their processing cease to exist, even though they have been processed lawfully.

You may submit your applications regarding these rights by completing the Data Subject Application Form of Torunlar REIC, available at www.torunlargo.com.tr, and sending it to us. Your request will be responded to as soon as possible, and at the latest within thirty (30) days, in accordance with the Law.
